Admin Report:

Chad Bybee

- 1. Inspection at Woodland Hills, phase one is being done. They were asked to move cabling off the sewer line.
- 2. Dishman storm water still needs approved. Dishman is working on streets now. The engineers from the City, Developers and Copper Rock are look at storm water.
- 3. Highway project at 125 and 60 has not had a lot of change. They are looking at ramp elevation and outer road locations.
- 4. Morelock Building construction is going quickly. Construction meetings went well.
- 5. Lakewood Estates- the JP Roy property has sold. Construction drawings for phase 1 were already passed by a previous administration. The City may need to review our storm siren policy with the subdivisions that are close together.
- 6. Trying to get a hold of a map from EPA on the Super Fund site and determine affected area around Compass Plaza.
- 7. GIS training was held. Discussion of what layers we will want on mapping was discussed.
- 8. Downtown streets will need to be paved or micro-sealed as soon as possible. We are looking at 1.04 miles of street that would cost around \$120K to micro seal.

Draft Ordinances

- Minor Subdivision to go to planning and zoning after requests are filed and to allow a minor subdivision plat to enhance the growth of the City.
- Allowing All-Terrain Vehicles being on roadways with-in the City limits.
- Park Trails Grant allowing Easements and trail access.

Board will review all ordinances and let City Staff know if there are questions. Ordinances will be in future Board meeting packets to possibly pass.

Butler Utility Account

A repair was made to the Butler's water line. The usage was very high over 2 months' time frame. Several issues on their end had to be repaired. The overage on this bill was also very high even after abatement. The Administrator asked the Board if they are willing to work out a payment plan, because of the overage being so high.
