Old Business:

Liquor License

Discussion was held on draft ordinance of 100 to 300 feet from Schools, Churches, and other family-oriented businesses for the sale of alcohol without permission from the Board. State is 100 foot but not defined as building to building or property line.

Mayor Cole recommends that the ordinance reads 300 feet, from property line to property line. He feels this will give the Citizens, Schools, and Churches the most protection. He does not want to restrict the board on what they have to allow.

Alderman Lee recommends 300 ft from door to door or building to building, not property lines and likes how the draft ordinance is written.

Alderman Pyle after research of other town and school officials recommends what is written by the state of 100 feet adding building to building and access to access if strip mall.

Alderman Stucki recommends keeping with the state and don't do an ordinance any different than the state has now.

Alderman Clarkson recommends 100 foot adding building to building or access to access in a strip mall.

Draft ordinance will be drawn up for 100 feet, building to building or access to access in strip mall.
